I am happy to have this opportunity to provide a statement on social surveys conducted and financed by the federal government on behalf of the National Association of Home Builders (NAHB).

NAHB is a Washington-based trade association representing more than 140,000 members involved in building and remodeling single family and multifamily housing, operating rental properties, manufacturing and distributing products, financing, and other aspects of residential construction. NAHB and its members thus have a strong demand for the information provided by federal statistical system, and have been strong supporters of federal surveys over the years.

As an organization, NAHB has an official policy on federal housing data. In 1989, NAHB's Board of Directors adopted a resolution urging the federal government to "maintain and improve the scope and quality of housing and housing information data that it collects and disseminates," and that resolution has remained in effect ever since.

NAHB and its members access the data produced from federal surveys and use it in a variety of ways on virtually a daily basis. For example, NAHB regularly tracks and forecasts series produced from federal surveys, such as those conducted by the Census Bureau's Manufacturing and Construction Division, to help its members make informed business decisions.

In some cases, NAHB combines data from the federal statistical system with other information. For example, the NAHB/Wells Fargo Housing Opportunity index combines house price data purchased from a vendor with local income estimates and property tax and insurance rates information from federal surveys to track housing affordability in metropolitan areas across the country. In an application like this, the data produced from federal surveys play a critical role and there is no substitute for them.

Even the information NAHB produces from its own surveys is often most useful because it can be benchmarked or compared to nationally representative data from the federal government. The NAHB/Wells Fargo Housing Market Index, which is monitored closely by the press, the Federal Reserve, and firms on Wall Street, has been useful and successful primarily because it can be shown to be a leading indicator of the series on housing starts, which is produced from a federal survey.

NAHB members who build and operate properties under federal housing programs rely on income and rent data from federal surveys to determine the eligible tenants and maximum rents, requires a data system that covers the entire country in a comprehensive, consistent way.

Much of the research NAHB undertakes in support of its policy positions relies on data from federal surveys. To illustrate the range and frequency of NAHB's use of federal survey data, recent examples are shown below. Major NAHB studies are shown going back to 2011. Shorter anlyses posted on NAHB's Eye on Housing blog are shown for approximately the past months. In each case, the federal survey or surveys on which the piece is based are indicated.
